## **OPEN HUMANS HEALTHKIT UPLOADER**

### **PRIVACY POLICY**

This privacy policy governs your use of the software application Open Humans Healthkit Uploader ("Application") for mobile devices that was created by Black Bear Software, LLC. The Application is a tool to upload HealthKit data from your mobile device to the Open Humans website for use by researchers.

## What information does the Application obtain and how is it used? User Provided Information

The Application obtains the information you provide when you download and register the Application. Registration with openhumans.org is required in order to upload data to the website.

When you register with openhumans.org and use the Application, no information is stored locally on the device or by Black Bear Software, LLC. The openhumans.org website is directly sent the aggregated HealthKit data, which will appear and be accessible on the openhumans.org data associated with your OpenHumans account.

## **Automatically Collected Information**

In addition, the Application may collect certain information automatically, including, but not limited to, the type of mobile device you use, your mobile devices unique device ID, the IP address of your mobile device, your mobile operating system, the type of mobile Internet browsers you use, and information about the way you use the Application.

Does the Application collect precise real time location information of the device? This Application does not collect precise information about the location of your mobile device.

# Do third parties see and/or have access to information obtained by the Application?

Your HealthKit data is publically accessible on the OpenHumans website, subject to any privacy settings that you select on the website itself. If you choose to make your data public, researchers and members of the general public will have access to your health data.

We may disclose User Provided and Automatically Collected Information:

- · as required by law, such as to comply with a subpoena, or similar legal process;
- when we believe in good faith that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate
  fraud, or respond to a government request;
- with our trusted services providers who work on our behalf, do not have an independent use of the information we disclose to them, and have agreed to adhere to the rules set forth in this privacy statement.

## What are my opt-out rights?

You can stop all collection of information by the Application easily by uninstalling the Application. You may use the standard uninstall processes as may be available as part of your mobile device or via the mobile application marketplace or network. To have your previously uploaded data removed from the OpenHumans website, use the tools available on your account management page on the website.

## Data Retention Policy, Managing Your Information

We will retain User Provided data for as long as you use the Application and for a reasonable time thereafter. We will retain Automatically Collected information for up to 24 months and thereafter may store it in aggregate. If you'd like us to delete User Provided Data that you have provided via the Application, please contact the OpenHumans project staff. Please note that some or all of the User Provided Data may be required in order for the Application to function properly.

### Children

We do not use the Application to knowingly solicit data from or market to children under the age of 13. If a parent or guardian becomes aware that his or her child has provided us with information without their consent, he or she should contact us at privacy@applicationsite.com . We will delete

such information from our files within a reasonable time.

## Security

We are concerned about safeguarding the confidentiality of your information. We provide physical, electronic, and procedural safeguards to protect information we process and maintain. For example, we limit access to this information to authorized employees and contractors who need to know that information in order to operate, develop or improve our Application. Please be aware that, although we endeavor provide reasonable security for information we process and maintain, no security system can prevent all potential security breaches.

#### Changes

This Privacy Policy may be updated from time to time for any reason. We will notify you of any changes to our Privacy Policy by posting the new Privacy Policy. You are advised to consult this Privacy Policy regularly for any changes, as continued use is deemed approval of all changes. You can check the history of this policy by clicking here.

#### **Your Consent**

By using the Application, you are consenting to our processing of your information as set forth in this Privacy Policy now and as amended by us. "Processing," means using cookies on a computer/hand held device or using or touching information in any way, including, but not limited to, collecting, storing, deleting, using, combining and disclosing information, all of which activities will take place in the United States. If you reside outside the United States your information will be transferred, processed and stored there under United States privacy standards.
